Issue: Discussion of Applicants for Purposes of Appointing Traffic Commissioners and Parks and Recreation Commissioners and Discussion on Potential Removal of Appointed Commissioner(s)

Recommendation: That the City Council: 1) Discuss the applicants for the Traffic Commission and the Parks and Recreation Commission interviewed on January 28, 2025; 2) Appoint Commissioners to four-year terms ending January 31, 2029, to fill three scheduled vacancies on the Traffic Commission and two scheduled vacancies on the Parks and Recreation Commission; 3) Discuss and take action on the potential removal of any appointed Commissioner(s); and 4) Appoint new Commissioner(s) to fill remaining terms of office for any unscheduled vacancies created as a result of any City Council removal(s) from office.

Background:

As of January 31, 2025, per Laguna Hills Municipal Code (LHMC) Section 2-28.070, the Traffic Commission has three vacancies and the Parks and Recreation Commission has two vacancies. When a commissioner's term expires, reappointment is not automatic and a Commissioner must reapply if they wish to continue to serve. The City Clerk's Department notified the existing Commissioners of their upcoming vacancies, sent a press release and published a separate legal notice for each Commission in the Saddleback Valley News announcing the notice of vacancies. The application period closed on January 3, 2025. The City received a total of eight (8) applications; two (2) for the Traffic Commission, four (4) for the Parks and Recreation Commission, and two (2) for either commission. The City Council conducted a brief interview of each applicant at a special meeting on January 28, 2025. Mayor Pro Tempore Caskey was unable to attend the January 28, 2025, interviews due to medical reasons and the Council decided

to delay any action until his return.

Section 2-28-.060 of the Laguna Hills Municipal Code authorizes the removal of members from any board or commission at the discretion of a majority vote by the City Council. The City Council may either appoint new commissioners to fill unscheduled vacancies resulting from such action or instruct the City Clerk to initiate a new application process to fill the vacancies.

Fiscal Impact:

Per Laguna Hills Municipal Code section 2-28.110, commission members shall receive no compensation.
